Unsound – not justified or consistent with national policy nor policies within this document. Points 2 & 3 This policy fails to recognise that by failing to limit the area of sites that can be considered infill in larger villages, major development sites may come forward outside of the Neighbourhood Planning process. To be consistent with policies for larger village sites, major development sites should only come forward through the Neighbourhood Planning process, otherwise this policy will inadvertently undermine the wishes of the local community and result in large unforeseen and unplanned development as shown by the recent appeal case in Chinnor – APP/Q3115/W/17/3187058. This case resulted in the approval of a major development of 140 dwellings on a site of nearly four hectares as the current local plan does not limit the size of an infill site in larger villages. The Planning Inspector also stated that "it is not necessary to have 4 or even 3 sides occupied by development nor are adjacent buildings to be hard up against the boundary." Furthermore, many other & smaller villages are long and straggling settlements, and as such this policy could mean they end up more than doubling in size.
