In so far as "exceptional circumstances" are provided in the Site Selection report they appear to be that the benefits that development brings to unlock infrastructure (including the proposed Culham Bridge) in this critical part of Science Vale far outweigh the harm (assessed as "high" in the Site Selection report) that green belt release would cause. This may be that the unexceptional circumstance is "unlocking" the Culham Bridge or it may be the housing supporting the Science Centre. In the former case there is no evidence that the Culham Bridge would fail to be "unlocked" if the specific site was not released. As for the housing it is just a tuppenny bus ride to be beyond the Green Belt and a short distance to the Vale's windfall previously developed site at Dalton Barracks capable of accommodating up to 7,000 homes of which only 1,200 are proposed in the Vale's own plan. These are not exceptional circumstances sufficient to outweigh the harm of Green Belt release as there are clear alternatives as required in para 137, and no exceptional circumstances to demonstrate why these should not be chosen.
