Park & Ride at Sandford

CPRE believes the remote Park & Ride strategy is fundamentally flawed. If Park & Rides must exist, they should from preference be located as close as possible to the areas from where people are travelling. The worst option is to locate them in rural sites between major settlements, which does nothing to reduce the number of car journeys but shifts congestion to rural roads and villages with inadequate supporting infrastructure, as well as impacting on the local landscape.

The proposed Park & Ride at Sandford would have a significant negative impact on the Green Belt, the landscape and the local community.

Policy STRAT4 paragraph 4 states that "Proposals must ensure that necessary supporting infrastructure is provided. Developers must engage with relevant infrastructure providers to ensure the implementation of the Infrastructure Delivery Plan." However, The National Audit Office report – Planning for New Homes¹ - 8 Feb 2019, points 16, 17 – 20 make it clear that "The way infrastructure is funded is complex, involves several government departments and private developers and lacks cohesion and certainty.", "The system to get contributions from developers towards the cost of infrastructure is not working effectively." "Developers can use the planning system to pay less in contributions than agreed." and "Contributions to the cost of infrastructure and affordable housing agreed with developers are not keeping pace with increases in house prices.

Each strategic site requires a significant amount of transport infrastructure to be delivered, many more than are listed under paragraph 1. It is clear from the lack of land identified as "Safeguarded" in TRANS 3, such as land required for bypasses for Stadhampton, Chiselhampton, and Cuxham (STRAT 7 para 2 ix)b), that there remains considerable barriers & cost implications to securing land to deliver the required infrastructure to mitigate against the damage that the strategic developments
