sites are expected to deliver nearly 6,000 more homes than this in the planning period, with an						
additional 4,000+ expected to be delivered after the planning period, with an

We believe that this paragraph suggests that the council expects sites to fail or be undeliverable, and						
has been developed only to meet deadlines for the Growth Deal.						
This "flexibility" is unsound, as it will allow developers to cherry pick sites and thus the council will						
lose any strategic control, and much needed infrastructure may not be delivered in the places it is
