Paragraph 5.12 recognises that “the overall level of development required to support the existing and future needs of South Oxfordshire, and a proportion to assist Oxford City in meeting its commitments of the Growth Deal amounts to 22,775 new homes” whilst the policies and strategic sites are expected to deliver nearly 6,000 more homes than this in the planning period, with an additional 4,000+ expected to be delivered after the planning period.

We believe that this paragraph suggests that the council expects sites to fail or be undeliverable, and has been developed only to meet deadlines for the Growth Deal.

This “flexibility” is unsound, as it will allow developers to cherry pick sites and thus the council will lose any strategic control, and much needed infrastructure may not be delivered in the places it is required.
